THE VIRGINIA SETTLEMENT AGREEMENT

A HISTORIC TIME FOR THE ID/DD CIVIL RIGHTS MOVEMENT

(the following information provided by the Arc of VA)

On January 26, 2012, the U.S Department of Justice (DOJ) and the Commonwealth of Virginia reached a settlement agreement regarding Virginia's services for people with intellectual and developmental disabilities (ID/DD). The provisions of this landmark agreement will help thousands of Virginians with ID/DD access community-based care.

A summary of key provisions can be found below. In essence, the settlement helps transform Virginia's developmental disabilities system from one heavily reliant on large, expensive institutions to one focused on safe, individualized, and cost-effective community-based services that promote integration and independence and enable individuals to live, work, and participate fully in community life.

The agreement calls for an overhaul of Virginia's ID/DD system, requiring the following:

- **4,170 additional ID/DD Waivers** between July 1, 2011 and June 30, 2021.
- Individual and Family Support Program for people with ID/DD whom the Commonwealth determines to be most at risk of institutionalization. A minimum of 700 individuals would be supported by the program in FY13. A minimum of 1,000 individuals should be supported by the program each year thereafter (FY14-FY21).
- Statewide Crisis System focused on prevention and planning to avoid crisis, as well as in-home community based crisis services that are directed at resolving crisis and preventing removal of an individual from current placement. Includes a 24/7 hotline, regional mobile crisis teams and regional community-based crisis stabilization programs.

- Supported Employment and Integrated Day Activities. VA will establish a statewide Employment First policy, which shall be based on the following principles:
 - Individual supported employment in integrated work settings is the first and priority service option for individual with ID/DD receiving day program or employment services from or funded by VA.
 - Minimum or competitive wages.
- Integrated Housing. VA will be required to develop a
 plan to increase access to independent living options such
 as individuals' own home or apartments. VA must also
 provide a one-time fund of \$800,000 to provide and administer rental assistance.
- Enhanced case management for individuals with more complex needs, who have experienced crises, are in congregate settings, or are receiving services from providers with conditional licenses
- Comprehensive oversight of safety and quality mechanisms for community-based services.
- A plan to the General Assembly to cease residential operations at four of VA's training centers.
- An Independent Monitor to assist in the implementation and to conduct biannual reviews.
- **The agreement is court-enforceable** should the Commonwealth fail to comply.

Governor McDonnell Signs Autism Legislation

On February 7, 2012 Governor McDonnell signed legislation that would provide a technical fix to the autism insurance mandate passed last year providing coverage for children 2 through 6. This year's bill provided a technical fix for promulgation of regulations for licensure for Applied Behavior Analysts within 280 days of the Governor's signing the bill.
